Considering the FIEP Statutes and the Common Declarations signed by the General Directors and Commanders of the FIEP Forces from 1994 to 2022, aiming at strengthening our partnership and developing concrete cooperation projects to improve the FIEP forces' operational answer to common security challenges, hence increasing overall security and stability;

Highlighting the Commission Meetings excellent outcomes on "Human Resources", "New Technologies and Logistics", "International Affairs" and "Service Organization" reflecting on the topic proposed by the Spanish Presidency "Impact of a regional conflict on public security in the field of Gendarmerie forces";

Emphasising, more specifically, the quality of the exchanges that took place as a result of a general recognition of the importance of identifying appropriate measures to mitigate the impact of regional conflicts. The exchange of experiences resulted in discussions on a broad array of issues ranging from recruitment and training processes, to capacity building, identification of the disinformation phenomena, or the importance of cyber security strategies/systems, while highlighting the significance of all state actors being involved when dealing with migration flows and environmental damages;

Taking into account the above paragraphs and the results achieved during the period between the 26th of October 2022 and the 25th of October 2023, during the Spanish Guardia Civil Presidency;

The commitment shown by all FIEP members related to the topic "Impact of a regional conflict on public security in the field of Gendarmerie forces", understanding that regional conflicts threaten our borders and change the security priorities in our societies. This topic paved the way for the designated Experts to develop a thorough analysis and in-depth discussions to achieve the main objective of the Spanish

Presidency for each Commission, inter alia:

- 1. Discuss the need to harmonize training or at least define common key elements in the instruction and training of police forces within FIEP.
- 2. Analyse cyber-threats to Public Order and how to manage them. Including both the formula for Gendarmerie Forces to influence new legislation and the operational and organizational methods necessary to face those threats.
- 3. Exchange knowledge in the main aspects affecting disinformation, in particular Legislation, Regulation, Situational Awareness and Operational aspects.
- 4. The exchange of information on environmental protection from a law enforcement perspective. Furthermore, share best practices on migration flow control and on the emergence of illicit trade, focusing on arms and human trafficking.

The Experts dedication throughout the meetings and the whole Presidency that made possible the upholding of the assigned tasks and a sustained exchange of information and experiences. The exchange of information should be promoted not only among all Members within the FIEP Association, but also at a bilateral level;
